

# Deer Valley Skyhawk Marching Band 2023 Membership Contract

In an effort to lessen the disparity between our team ideals and individual behavior, and to personalize these ideals for the 2023 marching season, Deer Valley Skyhawk Marching Band will adopt the following expectations of its members:

#### **SCHOOL BEHAVIOR:**

- 1. I will respect and abide by all school rules, regulations, and policies as required by DVUSD.
- 2. I will respect the dignity of all persons; therefore, I will not physically, mentally, or psychologically abuse or bully any person.
- 3. I will neither use nor support the use of illegal drugs, alcohol, or the smoking of any substance.
- 4. I will be in school on time every morning and I know I must be in school to be eligible to practice or participate in rehearsal that day.
- 5. I will strive for academic excellence and therefore; I will do my homework, go for extra help when needed, and do whatever it takes to strengthen my high school experience.
- 6. I will comply with instructions from all teachers immediately.
- 7. I will respect the property of others; therefore, I will neither abuse nor tolerate the abuse of property.
- 8. I will use language that is socially acceptable. Profanity, vulgar talk and obscene gestures will not be tolerated.
- 9. I will maintain a grade of D or higher in every class and understand if I do not, the instructor has the right to suspend me from participating for as long as my grade remains lower than a D.
- 10. I understand there will be a grade check every three weeks and I will be prepared to have my grades in on time.

#### **REHEARSAL BEHAVIOR:**

- 1. I will use language that is socially acceptable. Profanity, vulgar talk and obscene gestures will not be tolerated.
- 2. I will cooperate with teammates, instructors, and any special guest present.
- 3. I will arrive with my equipment and water for all practices and scheduled performances.
- 4. I will be on time for practice and team scheduled events.
- 5. I will comply with instructions from all instructors.
- 6. I will wear attire required for rehearsals.
- 7. I will exhibit good sportsmanship on and off the field.

### **COMMUNICATION:**

#### 1. Rehearsals

- a. Once a rehearsal calendar is handed out, students will be responsible for attendance to all scheduled rehearsals.
- b. Students must turn in a list of conflicts to instructors within 2 weeks of receiving the rehearsal calendar. Absences must be explained so that instructors may determine whether or not it will be an excused absence.
- c. Missing rehearsal without at least a 2 week notice could result in the student not performing the next show. This will be decided on a case by case basis by instructors.
- d. If missing rehearsal due to illness, please have a parent/guardian contact the instructor AND Mrs. Govan.
- e. All communication for missing rehearsals needs to be communicated to the instructor AND Mrs. Govan through a private group message in SLACK.
- f. Excused absences do not guarantee performance. Instructors reserve the right to determine whether or not a student performs based on what is best for the entire group.
- g. If students miss the rehearsal before the performance for any reason, the student will not perform at the Performance.

#### 2. Performances

- a. Once a performance calendar is handed out, students will be responsible for attendance to all scheduled performances.
- b. Students must turn in a list of conflicts to instructors within 2 weeks of receiving the performance calendar. Absences must be explained so that instructors may determine whether or not it will be an excused absence.
- c. Missing a performance without at least a 2 week notice could result in the student not performing the next show. This will be decided on a case by case basis by instructors.
- d. If missing a performance due to illness, please have a parent/guardian contact the instructor AND Mrs. Govan through a private message on SLACK.
- e. Students must have ALL performance materials on the day of the performance. Failure to bring something needed for the performance will result in the student not being allowed to perform.
- f. Missing a competition without at least a 2 week notice could result in the student not performing in Semi-Finals. This will be decided on a case by case basis by the Director.
